Publication fees are charged when the use of a photograph or other reproduction is, in the judgment of the Gwinnett Historical Society, deemed commercial. The use of an image in any vehicle that is a for-profit venture, such as a theatrical movie or play, a mass market trade publication, advertising, decoration in a restaurant, inclusion on a web site, or in any other profit-making enterprise is subject to payment of a publication fee.

Documentaries intended for airing on public television are also subject to such a fee.

Print Media/Editorial/Textbooks and E-Books/E-Journals, publication up to 10,000—\$40 per image

For profit/Commercial advertising, merchandising, or inclusion on a web site - \$40per image

Publication fees are charged per image, over and above those fees charged for the cost of reproduction. Fees are for a one-time use, but with worldwide rights, English language. Upon publication, the Gwinnett Historical Society must receive one complimentary copy of the publication/broadcast in which the image appears.

Copies in any format (including use on a website or social media) may not be reproduced, sold, shared, or given to another person, company, or institution for any purpose without the written permission from the Gwinnett Historical Society. They may not be used in the future for additional projects without the written permission from the Gwinnett Historical Society and payment of additional user fees.

NOTICE CONCERNING COPYRIGHT RESTRICTIONS:

The copyright law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyrighted material. Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or other reproduction. One of these specified conditions is that the photocopy or reproduction is not to be used for any purpose other than private study, scholarship, or research.
